1.22 Sun Protection All Year

Policy statement

Glebe House School comply with health and safety regulations and the Welfare Requirements of the EYFS in making our setting where possible a sun safe environment - outdoors.

At Glebe House School we acknowledge the importance of sun protection in winter and summer and want staff and children to enjoy the sun safely. We will work with staff and parents to achieve this through:

EDUCATION - these measures are in place:

- All children will have a Sun Safe story time on a regular basis before and during the summer term.
- Children will be encouraged to look at Sun Safe pictures, games, activities etc to reinforce the sun protection messages, such as wearing hats, putting cream on etc
- Children will be encouraged to drink plenty of water to ensure they do not dehydrate
- We are adding a Sun Safe songs to those we normally sing around this time of year.
- Parents and guardians will be sent a letter explaining what we are doing about sun protection and how they can help at the beginning of the summer term and during summer holidays.
- All staff will be informed of the importance of sun safety and information will be made available in the staff room.

PROTECTION – this is more of an ongoing process

Shade:

- We will encourage students to sit/play in the shade where it is available.
- We have gazebo to provide instant shade when we have specific events such as Summer Show and Sports Days when extra shade may be required.
- Children are also encourage to rest in the shade of the Forest School Shed if they are tired or want to play sitting down.

Timetabling:

- Children will spend more time playing outside before 11am and after 3pm, and less time outside over lunch.

Clothing:

- Children are required to wear hats that cover the ears, face and neck between 11 and 3.
- We have some nursery hats to give to children who forget their own.
- All staff have also agreed to wear hats when outside to set a good example.

Sunscreen:

- We send letters home asking for permission for staff to supervise children applying sunscreen before going outside during the summer months, those who can't apply it will be helped by staff
- Children will need to bring in their own clearly labelled bottle of sunscreen, at least factor 15+.
- We do not currently supply sunscreen to all children on a daily basis because of cost and risk of allergy reactions to certain types of creams, but will provide an emergency supply in case children forget theirs
- In the event of parents forgetting cream, staff will either phone them and ask if they can use the named emergency supply suncream (checking they are not allergic to it) or children will wear clothes which protect them from the sun and only remain in the shade outside for maximum of 15 minutes, before having to return inside to protect them from the sun's harmful rays

This policy was developed with the help of staff, parents and local health advisors in March 2011.

We will monitor our progress and review the policy annually.

Dear Parent/Carer,

Now the summer is approaching I wanted to write and tell you about our new sun protection policy. We have developed this with the help of the SunSmart Cancer Research UK Charity, to ensure that we can all enjoy the sun safely over the coming months.

As you all know the sun's rays are particularly strong over the summer and they can damage children's skin. This may not seem like a problem right now, but sadly it can lead to skin cancer in later life. Your child's health and well-being are very important to us. So we have decided to:

- spend more time discussing sun protection at nursery
- increase the shade in our playground
- actively encourage all children to wear a hat when they play outside. Please send your child to nursery wearing a comfortable wide brimmed hat or legionnaire style cap. We also have some nursery hats to give to children who forget their own.

If your child is fair skinned it may be a good idea to provide additional protection with appropriate clothing, but all children should wear sunscreen with a factor of at least 15+. Staff at Glebe will be supervising children applying sunscreen and helping those that are not able to apply sunscreen by themselves. If you would like your child to be included please return the sunscreen permission form with a bottle of factor 15+ sunscreen clearly labelled with your child's name.

Parents' support is very important if our new policies are going to work. You can help by:

- talking to your child about the importance of sun protection at home and in nursery
- remembering to send your child to nursery with a wide brimmed hat and suncream

Together I hope we can have a very happy and safe term to come!
