# 4.6 Working in partnership with other agencies

#### **Policy Statement**

We work in partnership with local and national agencies to promote the well-being of all children.

#### **Procedures**

- We work in partnership or in tandem with, local and national agencies to promote the wellbeing of children.
- The Manger or Deputy Manager in her absence, communicate regularly with other agencies within the community such as Health, Early Childhood and Family Services (ECFS), Childminding Matters, Adult Education, Home Start, Early Help, Pandora etc and refer any knowledge back to relevant departments in the school.
- The Area Manager chairs our own Early Years Peer Support Groups which meets at least termly and invites guest speakers from Health, Early Help etc to update us on services within the community, as well as sharing information and training, so together we can improve quality for all children and families within the community.
- Procedures are in place for sharing of information about children and families with other agencies; please see relevant consent forms for Information Sharing. These are set out in

- the Information Sharing Protocol, Safeguarding Children procedures and the Special Educational Needs and Disabilities Procedures.
- Information shared by other agencies with us is regarded as third party information. This is also kept in confidence and not shared without consent from that agency.
- When working in partnership with staff from other agencies, we make those individuals welcome in the setting and their professional roles are respected.
- We follow the protocols for working with agencies, for example on child protection.
- Staff from other agencies do not have unsupervised access to the child they are visiting in the setting and do not have access to any other child(ren) during their visit.
- Our staff do not casually share information or seek informal advice about any named child/family.
- When necessary we consult with local and national agencies who offer a wealth of advice and information that help us develop understanding of issues facing us and who can provide support and information for parents. For example, ethnic/cultural organisations, drug/alcohol agencies, welfare rights advisors or organisations promoting childcare and education, or adult education.
- We have members of staff who have been on various Early Support training sessions, and various publications are available in the Nursery Office for staff to update their knowledge or share information with parents who require support for recent diagnosis of SEND.
- Our staff are aware of Early Help Assessment Plan (EHAP) and several staff have now attended the necessary training to make referrals if needed.

N.B. Various publications are available in the Nursery Office to support parents about numerous issues they may have, and if we can't find the right one we will research how to help them through consulting other agencies such as ECFS, Early Help etc.
